- To protect public health during a global pandemic, **the Center for Disease Control issued an Order that halts an eviction after a homerenter (tenant) sends a Declaration to their landlord.** Homerenters do not have these eviction protections if they do not send the Declaration to their landlord.

• **IT IS CRITICAL THAT YOU ATTEND YOUR EVICTION COURT HEARING,
EVEN IF YOU ARE BEHIND ON RENT.**

• You are eligible for additional time to resolve matters with your landlord, **BUT ONLY IF YOU ATTEND YOUR COURT HEARING.**

• Due to COVID-19 court hearings are held virtually/on-line instead of in person. Jefferson County Eviction Court is being held via Zoom. You can also access this through a computer, tablet, or smartphone. You can also call in on your phone.

• You will receive a ZOOM link & phone number in your court paperwork and a time of day to log in on-line or call by phone. (i.e., 9:00 AM 10:00 AM 11:00 AM)

• Be present at the ZOOM (on-line) eviction hearing because there will be agencies present on the ZOOM to help you pay your past due rent!

• Be sure to **log in on-line by computer or call by phone on the day and time listed on your paperwork.** If possible, log in a few minutes early in case you are first on the docket.
